New businesses that come to Horicon will have the first fiscal year free.

One business can transfer its membership to another business starting, as long as the prior business has closed or moved out of town and owned by the same person or group.

Member fees can be refunded only on a case by case basis. This must be approved individually by the board. Generally fees cannot be refunded.

Each business in Horicon must pay for membership even if owned by the same person or group who has a different chamber business at same address.

Two of the same businesses at different locations may pay only one membership fee as long as they pay for all employees of both locations.
